For the first time, you can also see your experience for the current period reported against the last period, enabling direct comparison.

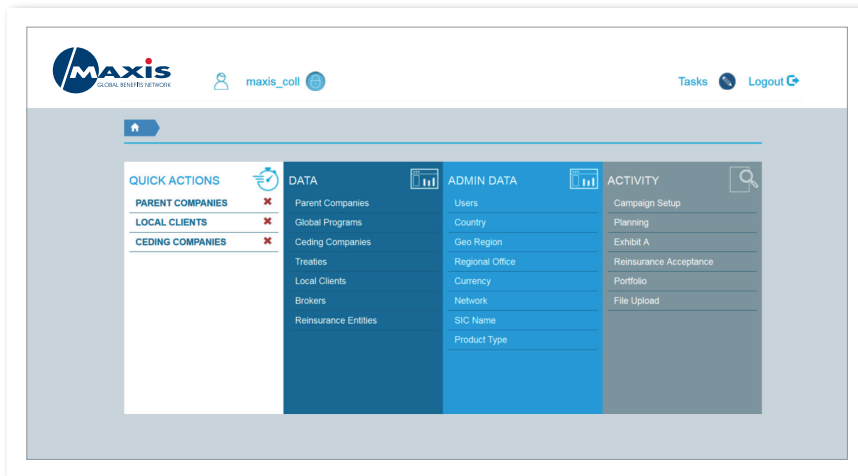
Enhancements to BRIDGE are being implemented during 2017 and 2018.
